5. The common stock was purchased by the reporting person in open market transactions on the transaction date, with a volume weighted average purchase price of \$1.8358. The range of purchase prices on the transaction date was \$1.77 to \$1.88 per share. The reporting person undertakes to provide, upon request by the SEC staff, the issuer, or a security holder of the issuer, full information regarding the number of shares purchased at each price.
